COURSE DESCRIPTION

The content of this course relates closely to the content covered in ECS 311 and other Curriculum and Methods courses occurring during the same term, because this course provides opportunities to plan lessons and to put into practice the theory learned in ECS 311 and reflect upon students' field experiences.

Other YNTEP courses occurring in the same term will not occur during field placements as students will be delivering lessons; conducting observations and completing assignments in the field based on course requirements. Instructors will ensure that assignments are provided in advance of the placements.

PREREQUISITES

Completion or enrolment in ECS 311. Permission from the Program Area is required to register.

RELATED COURSE REQUIREMENTS

Access to course Moodle via a computer and internet access.

LEARNING OUTCOMES

Upon completion of this practicum, students will:

- plan and prepare detailed lessons for students in assigned classroom(s);
- practice teaching the lessons they have planned;
- practice the professional development cycle;
- debrief their school teaching experiences with university instructors and their peers;
- reflect upon their teaching experiences;
- be able to deconstruct teaching practices in light of various philosophies of teaching and begin to develop their own philosophy of teaching and learning;

- integrate into their teaching knowledge, skills, processes, and professional attitudes developed throughout the semester;
- participate in modules and workshops related to teaching for social justice.

COURSE FORMAT

This practicum is a two-week, full time school placement.

EVALUATION - PASS / FAIL

To achieve **PASS** in EFLD 310 a student must:

- **Summative:** receive a "Pass" from the cooperating teacher on the final Professional Profile (IPP).

EVALUATION - ADDITIONAL REQUIREMENTS

In addition to the requirement listed above, students will submit a completed practicum binder that includes:

- Complete Evaluation Form (by cooperating teacher)
- Overall Practicum Reflection (max two pages)
- Prepare four formal lessons. During delivery of these lessons, the cooperating teacher to observe and provide feedback. The Professional Development Model will be used for each of the demonstration lessons.
- Complete Curriculum Orientation Analysis for two lessons.

Attendance

Attendance is mandatory. Full attendance and punctuality are expected as you join a professional learning community.

Plagiarism can be the deliberate use of a whole piece of work, but more frequently it occurs when students fail to acknowledge and document sources from which they have taken material according to an accepted manuscript style (e.g., APA, CSE, MLA, etc.). Students may use sources which are public domain or licensed under Creative Commons; however, academic documentation standards must still be followed. Except with explicit permission of the instructor, resubmitting work which has previously received credit is also considered plagiarism. Students who plagiarize material for assignments will receive a mark of zero (F) on the assignment and may fail the course. Plagiarism may also result in dismissal from a program of study or the College.
