COURSE DESCRIPTION

In this course, we continue exploring the science of money management in a corporate context. The focus will be fundamentally about how firms value, assess, and mitigate risk across a variety of contexts, including capital budgeting, international finance, leasing, and mergers and acquisitions.

COURSE REQUIREMENTS

Prerequisite(s): Successful completion of Acct101, Acct102, and Acct213.

LEARNING OUTCOMES

Upon successful completion of the course, students will be able to:

- 1. Understand the relationship between risk and return.
- 2. Understand the relationship between the cost of capital and long-term financial policy.
- 3. Understand the role played by currencies and exchange rates in international finance.
- 4. Understand the role of derivative securities.

COURSE FORMAT

Course content will be presented through a blended approach of independent online study and weekly 2-hour classes. Students will be required to attend each week's class having

- 1. completed all relevant readings (2 hours),
- 2. watched all relevant instructional videos (1- 2 hours), and
- 3. attempted the in-class study exercises (2- 4 hours).

Classes will be taught on the assumption that students are fully prepared for class and are thus familiar with the necessary content for the week. As such, much of class time will be devoted to hands-on application of course theory through collaborative problem solving.
