#### **COURSE DESCRIPTION**

This practical course offers students the opportunity to acquire personal care and assistance skills within the parameters of the HCA role. The course is comprised of class and supervised laboratory experiences which assist the student to integrate theory from other courses to develop care-giver skills that maintain and promote the comfort, safety and independence of individuals in community and facility contexts. This course is the introduction to Personal Care and focuses on basic skills and knowledge.

#### **COURSE FORMAT**

# Weekly breakdown of instructional hours

Classes are 6 hours long (full day) over 10-11 weeks. Classes involve direct instruction time; including theory & practice of related skills in the nursing lab. Class time for skills testing and the final written exam are also scheduled. It is expected that this course will require 2-4 hours of homework and additional reading for each class. The time required will vary by individual.

# **Delivery format**

This course will be delivered through face-to-face sessions on-campus in the Nursing Lab. Students will be required to adhere to public health guidelines. More information about the specific precautions will take place during the HCA orientation in August.

This course will integrate classroom theory with demonstration and practice of the skills to be learned. Students will learn concepts of personal care and will practice with other students in the lab to gain competence. Mini-lectures, readings, discussions, reflection, guest speakers, demonstrations, role-playing, and other appropriate learning experiences may be utilized. Students will be guided re: appropriate clothing for lab practice to ensure safety and comfort.

Students are expected to attend class and may be required to complete assignments and/or activities online or individually.

#### **TOPIC OUTLINE**

## Problem-solving when carrying out care-giving procedures

- Assessing the client/resident and the situation prior to commencing care
- o Identifying unsafe environments or situations.
- Seeking assistance if necessary in order to maintain the safety of the client/resident and/or the care provider.
- o Organizing equipment and supplies in order to efficiently complete tasks.
- Checking equipment for safety and functionality.
- o Reporting equipment malfunction.
- o Performing the procedure(s).
- Maintaining client/resident privacy and dignity.
- o Encouraging independence and self-care as much as possible.
- Cleaning equipment after use and returning to appropriate place.
- Tidying the resident/client's environment.
- Evaluating effectiveness of the procedure.
- Reporting and recording actions, results and observations.

#### Asepsis and Prevention of Infection

- Standard and routine precautions.
- o Hand Washing.
- o Gloving & PPE
- Isolation precautions
- Principles and practice of medical asepsis in facilities and community settings
- Current Issues in Infection Control & Dealing with "super bugs"

## Promoting personal hygiene

- Oral hygiene.
- o Bathing bed bath, tub baths and showers.
- o Providing perineal care.
- o Assisting with grooming and dressing.
- o a.m. and h.s. care.
- Back massage and skin care.

## Moving, positioning and transferring a client/resident

- o Body mechanics in the home and facility.
- o Turning a person in bed.
- Using positioning devices.
- o Assisting with transferring and moving a person in a hospital bed and a regular bed.
- o Transferring a person to a stretcher.
- o Moving a person to the side of a bed and assisting him/her to sit.
- o Transferring a person from bed to chair or wheelchair and back.
- o Transferring a person from a wheelchair to a bath chair or toilet.
- Using mechanical lifts including ceiling lifts.
- Assisting the individual to use a walker safely.
- Assisting with ambulation.
- Dealing with falls.

#### **Bed making**

- Making a closed bed.
- Making an open bed.
- Making an occupied bed.

## Promoting healthy nutrition and fluid intake

- o Practicing safe food handling and storage.
- Using food preparation equipment.
- Serving meals in ways that encourage normalizing interactions.
- Assisting clients/residents with eating and drinking.
- Utilizing safe eating assistance techniques with individuals who are experiencing difficulty biting, chewing and/or swallowing.

Cleaning equipment, dishes, and utensils after use.

## Assistive Devices, Adaptive Devices, Prosthetic Devices

- o Vision, Hearing Devices and Care of same
- o ADL Devices, etc.

## Indigenous Knowledge/Perspectives

- Culturally Safe Care:
  - Respecting indigenous healing practices and understanding the importance of these in caregiving
  - Trauma-informed approach with care: i.e. giving intimate care, such as perineal care
- Respectful, culturally appropriate communication with First Nations persons (in particular Elders). *This is also noted in other courses.*
- o Incorporating the knowledge, wisdom and teachings of First Nations Elders, when appropriate, to help students understand care skills through a more culturally safe lens.
