## COURSE DESCRIPTION

This course will explore many of the aspects of land and water management in the including the historic factors that have influenced how land management has developed. A large component of the course will deal with existing laws and policies that deal with land management and planning including relevant chapters of the Yukon Umbrella Final Agreement and land claims. Understanding these agreements is necessary to understand and appreciate the management of natural resources in the Yukon.

## LEARNING OUTCOMES

Students who successfully complete all components of the course will be able to

- 1. Explain what land management is and list its main components. Specific focus will be on how land is categorized and managed in the Yukon, and
- 2. list the main historic factors and events that have affected land management in the Yukon and explain how these have influenced the current land management regime,
- 3. identify the different categories of land in the Yukon and know the steps involved in determining who has jurisdiction for:
  - a. Categories of private land (e.g. fee simple, settlement lands); and,
  - b. Categories of public lands,

- 4. explain how different lands are managed in the Yukon. Students will work with different case studies to learn about the role of policy, planning, regulation and legislation in land management and the specific regulatory framework that is in place to deal with different types of activities on Yukon lands and
- 5. describe the process established by the land claim agreements to manage land and how these processes fit together.

# **DELIVERY METHODS**

The course will be delivered by 3 hours of lecture per week with supplementary online materials and discussion.

## COURSE FORMAT

The course will include 3 hours of lecture per week, with assigned readings, lectures, discussions, examinations and written assignments.

## **COURSE REQUIREMENTS**

#### ASSESSMENTS Attendance

Opportunities to make-up work or testing events that have been missed as a result of excused absences will be determined on a case-by-case basis. Missed work that results from unexcused absences cannot be made up.

## Participation

Students are expected to participate in the in-class and online discussions in order to receive full-value from the information provided in the readings and lecture.

## Assignments

There will be three assignments based on the lectures, class readings and case studies. The assignments will make up 50% of the final mark.

## Projects

One semester-long independent project (Assignment #3) will be assigned at the beginning of the semester with completion at the end of the semester and include an oral presentation.

## Tests

There will be a mid-term exam (20% of the final mark) and a final exam (30% of the final mark).
