#### **COURSE DESCRIPTION**

Environmental and socio-economic effects assessment ensures that the effects of development activities are considered before they happen and that significant adverse effects will be mitigated. In taking this course, students will gain an understanding of the following aspects associated with assessments:

- History and continuing evolution of assessment process.
- Reasons for conducting assessments
- Assessment timelines and process.

- Creating an opportunity for public participation and engaging interested persons in the process.
- Understanding what information is required, determining the relevance and validity of information and incorporating information into assessments.
- Creating a recommendation with written reasons.
- Professional ethics, due diligence and other aspects of professionalism associated with assessment.

### **DELIVERY METHODS/FORMAT:**

The course consists of two 1.5-hour lectures per week.

# **PREREQUISITES:**

For students taking the course as RRMT 238: Admission to the second year of the Yukon College Renewable Resources Management Program.

For students taking the course as ENCS 307: Registration in Yukon College/University of Alberta B.Sc. in Environmental and Conservation Sciences degree program.

# **Attendance and Participation**

Attendance is mandatory. Unexcused absences from more than 10% of activities may result in a failing grade.

## **Assignments**

Material will be presented in lectures, readings, discussions, case studies and assignments. Emphasis of assignments will be the development of a familiarity with information sources and practical methodologies used to carry out initial development assessments. Assignments will involve review and critique of assessments of typical proposed development projects. Results will be reported in writing and by presentation to the class.

#### **Exams**

There will be one midterm exam and one final exam. The midterm will be scheduled during class time on Feb 26. The final examination will be held at the end of term, during the scheduled

College exam period.

# **30.3.2(1) Plagiarism**

# **30.3.2(2)** Cheating

**30.3.2(2)** a No Student shall in the course of an examination or other similar activity, obtain or attempt to obtain information from another Student or other unauthorized source, give or attempt

to give information to another Student, or use, attempt to use or possess for the purposes of use any unauthorized material.

- **30.3.2(2) b** No Student shall represent or attempt to represent him or herself as another or have or attempt to have himself or herself represented by another in the taking of an examination, preparation of a paper or other similar activity. See also misrepresentation in 30.3.6 (4).
- **30.3.2(2) c** No student shall represent another's substantial editorial or compositional assistance on an assignment as the Student's own work.
- **30.3.2(2) d** No Student shall submit in any course or program of study, without the written approval of the course Instructor, all or a substantial portion of any academic writing, essay, thesis, research report, project, assignment, presentation or poster for which credit has previously been obtained by the Student or which has been or is being submitted by the Student in another course or program of study in the University or elsewhere.
- **30.3.2(2)** e No Student shall submit in any course or program of study any academic writing, essay, thesis, report, project, assignment, presentation or poster containing a statement of fact known by the Student to be false or a reference to a source the Student knows to contain fabricated claims (unless acknowledged by the Student), or a fabricated reference to a source.

# 30.3.2(3) Misuse of Confidential Materials

No Student shall procure, distribute, or receive any confidential academic material such as pending examinations, laboratory results or the contents thereof from any source without prior and express consent of the Instructor.
